Council Pro Temp Stefania Kuehner opened the meeting and the following members of Council were present: Donna Heist, Carol Kienzle, Angelo Lello, Clifford Mays, Jr., Robert Ross and Mason Wright.(Not present Edward Dennis and Pat Moran)

Council President Dennis called the meeting to order and made the following announcement:

Council President Dennis stated the meeting is being videotaped to air on Channel 97 and the City Website.

Mayor Presentation: Mayor Jiampetti gave the Oath of Office to the new EHC Special Resource Officer, Class III Edward Riegel.

Mr. Ricci stated he is looking into holding CPR classes in the City and hoped to donate proceeds to local organizations. Kelly Waters of St Louis Avenue expressed concerns over the time Halloween is held in EHC. Ms. Waters thought 6pm-8pm was late.
