4. “The News”, “The Press”, “The Current” and “The Hammonton Gazette” are hereby designated Official Newspapers for the publishing of all Legal Notices of Common Council of Egg Harbor City.

5. The City Clerk shall mail a copy of this resolution, together with advance notice of Regular, and Special Meetings of the Common Council to the newspapers named in paragraph 4.
6. The City Clerk shall file a copy of the schedule of Regular Meetings of Common Council in the Official Files of Egg Harbor City.
7. The City Clerk shall file a copy of advance notices of all Regular and Special Meetings of the Common Council in the official files.
8. The City Clerk shall post notice of Regular and Special Meetings of the Common Council at least 48 hours in advance on the bulletin board located in the Egg Harbor City Municipal Complex, 500 London Avenue, Egg Harbor City.
9. Any person may request in writing that the Common Council mail to him/her a Copy of the schedule of the Regular, Special or Rescheduled Meetings of the Common Council. Upon pre-payment by such person of the applicable fee hereafter set forth, such scheduled and/or advance notices shall be mailed to such person. All requests made pursuant to this paragraph shall terminate at midnight December 31, 2020 of the current year, subject to renewal thereafter upon filing of a new written request to the Common council together with pre-payment of the Applicable fee:

 - a) the agenda, and
 - b) those matters upon which formal action may be taken

Upon the affirmative vote of $\frac{3}{4}$ of the Council Members, the Common Council May hold a meeting without compliance with the notice requirements of this Resolution if such meetings is required to deal with matters of such urgency and Importance the delay for purpose of providing adequate notice would be likely to Result in substantial harm to the public interest.
