CFO Jodi Kahn reviewed "Budget Draft" she prepared and provided to Council, a copy of the budget draft is attached hereto and made a part of these minutes.

The Budget Workshop was adjourned at 6:50pm upon motion of Trythall and seconded Heist.

# Regular Council Meeting:

## Mayor Report and Comments:

Mayor Jiampetti stated there will be a Public Information Meeting to discuss the proposed Cedar Creek/Egg Harbor Lake Pedestrian connection at City Hall on February 12, 2020 from 4:00pm to 6:30pm. Michael Troncone of Consulting & Municipal Engineers will be giving hosting the Public Information Meeting. Mayor Jiampetti stated the Public Information Meeting will be followed by a presentation to City Council at its meeting on February 13, 2020. Mayor Jiampetti spoke on the cops grant. Mayor Jiampetti stated the EHC Tax Collector Laura Shaw will be coming to the second meeting in February to explain the foreclosure and accelerated tax sale procedure to Council members. Public Comment: Marie Johns of Liverpool Avenue came before Mayor and council. Ms. Johns expressed her displease with the Code Enforcement Department. Ms. Johns stated there are many properties that could be looked into due to violations. Ms. Johns expressed concerns over drug activity in the her neighborhood. Ms. Johns asked if the NNP money could be used to improve the Log Cabin on Philadelphia Avenue and Mayor Jiampetti stated the NNP Grant Coordinator is looking at different options. Kath Timbers of London Avenue came before Mayor and Council Mr. Timbers spoke on the WIPA Process and stated EHC is the first in NJ to use the WIPA process. City Engineer Ryan McGowan stated that was true. Mr. McGowan gave an update on the WIPA process. Scott Senn, 310 Washinton Avenue came before Mayor and Council. Mr. Senn had questions regarding the sale of the EHC Water & Sewer treatment Facility. City Engineer McGowan addressed all Mr. Senn's questions. Keith Adams, 520 Boston Avenue came before Mayor and Council. Mr. Adams expressed his pleasure with the return of the after school program in the EHC. Mr. Adams thanked Mayor Jiampetti for all her hard work with the program. Mr. Adams stated he use to work for the EHC Utility Department full time and now works part time in the department. Mr. Adams stated he is very upset with the proposed sale of the EHC Water & Sewer Treatment Facility. Mr. Adams stated EHC has a state of the art facility, the department currently provides top notch service and has home rule. Mr. Adams questions what kind of service the EHC residents will have once the utility is sold. Teddy W, 158 San Francisco Avenue cam before Mayor and Council. Mr. W was very upset with an EHC Site on social media and asked if there was anything the City could do to shut down the site. Mr. W. stated horrible things are posted on the site about EHC. Mr. W. stated when you search EHC on the internet this particular site is the first to come up. Mr. W stated the person who runs the site is a resident of EHC and members of Council are on the site. He questioned why members of Council would be on the site and asked them to speak to the administrator of the site. City Attorney Angela Costigan stated there is not much you can do due to freedom of speech. Members of the Public suggested an injunction, Mr. W asked if the City IT person could do something and the Mayor stated she would ask. Anthony DaGrosso of St. Louis Avenue came before Mayor and Council. Mr. DaGrosso stated he was unhappy with the house next to him. Mr. DaGrosso stated there is construction being done on the home all hours of the day and there are no permits to do the work. Council Pres. Lello stated he would notify Code Enforcement. Reed Cramer of 137 Chicago Avenue came before Mayor and Council. Mr. Cramer stated he was very upset over comments Councilman Mays made at the January 3, 2020 Re Organization meeting. Mr. Cramer stated these comments were made to the press and published in the paper. Mr. Cramer stated the comments were about him and he is contemplating legal action against the City and Councilman Mays. Mr. Cramer stated he has suffered due to the comments. Mr. Cramer stated he wants a public apology from the Councilman Mays or he will take legal action. Amy Cramer of 137 Chicago Avenue came before Mayor and

Council. Ms. Cramer stated Reed Cramer is her husband and the comments made by

Councilman Mays have caused her husband great anguish.
