ORDINANCE #5- 2020

**AN ORDINANCE TO AMEND PART II, GENERAL LEGISLATION,
CHAPTER 198 TITLED PARKS AND RECREATION AREAS ARTICLE I
AND ARTICLE IV OF THE CODE OF THE CITY OF EGG HARBOR**

WHEREAS, the City of Egg Harbor determines that it needs to protect and promote the public health and welfare of its residents; and

WHEREAS, the City of Egg Harbor wants to ensure the enjoyment and use of the municipal facilities in an orderly manner and to have a basis for enforcement of violations of Rules promulgated hereunder which are intended to ensure a harmonious and peaceful utilization of the facilities by its residents; and

NOW THEREFORE, BE IT ORDERED by, the Mayor and Council of the City of Egg Avenue, County of Atlantic and State of New Jersey, that Chapter 198, Article 1 is amended as follows:

§198-3. Fees; Badges.

D. Appropriate badges must be visible.

E. Badge fees are not refundable.

§198-4. Bathing Restricted.

Bathing is only permitted when lifeguards are on duty from 10:00 a.m. to 6:00 p.m. No swimming is permitted on North Beach.

§198-6. Pets Prohibited.

No dogs are permitted except service dogs.

§198-8. Fires Restricted.

No fires or outside grills shall be permitted except in the areas designated for such purpose. Designated areas are South Beach and campground. No outside grills are permitted in the Lake Park area, Pavilion (unless paid) or North Beach. No outside grills and fires are permitted on North Beach.

§198-10. Persons permitted in parks after hours restricted.

No one shall be permitted within the South Beach area before Dawn and after Dusk.

§198-11. Camping; Fees.

F. No picnics, fires or outside grills are permitted on North Beach. No overnight camping is permitted in any city-owned park, playground or property. Camping is permitted only in designated camping areas with permit.

G. This section is governed by the “Campground Facilities Act,” N.J.S.A. 5:16-1 et seq.

§198-12. Vehicle Speed Limit.

Limit of speed shall be 5 mph.

§198-14. Use of Pavilion; Permit required; Fees.

The Pavilion on the northeasterly side of the City Park Lake and its surrounding area shall be available for the use of groups upon request and approval of the current campground operator at rates set forth by the same.

The following shall be added:

§198-17. Prohibited Activities.

- a. No throwing rocks or sand.
- b. No sitting, picnicking, grilling, swimming or camping on lake wall or surrounding perimeters of the lake.
- c. Children under 13 years old must be accompanied by an adult.
- d. No diving, flipping or pushing off the dock.
- e. No rafts, tubes or other floating device is allowed on the dock.
- f. No gasoline powered engine is allowed on beach or lake. Supply delivering vehicles are excluded.
- g. Children unable to swim cannot be present or carried to dock.
- h. Alcohol or illegal drugs are prohibited.
- i. Children learning to swim must have protective floating devices.
- j. Picnic tables must be rented before using. Stand tables are only to be used by stand customers.
- k. No outside vendors are permitted in lake or campground area until after 7:00 p.m. and may remain until 10:00 p.m.
- l. All vendors must possess a valid mercantile license.
- m. No unloading is permitted at or near fence.
- n. No feeding of wildlife.
- o. No quad vehicles are permitted.

§198-18. Exclusion

This ordinance is not applicable to Lot 101-Block 954, also known as 2500 Philadelphia Avenue.

BE IT FURTHER ORDERED by the Mayor and Council of the City of Egg Harbor, County of Atlantic and State of New Jersey that Chapter 198, Article IV is amended as follows:

§198-23. Conditions for rental; fees.

B (1) amended to read:

Lake Pavilion. Current badge price set forth by Ordinance.

B (3) amended to read:

Lake side Gazebo: \$25.00 per event. Gazebo is booked through lake manager or tax collector. Daily wristband badge purchase at current badge price set forth by ordinance.

BE IT FURTHER ORDAINED, that if any portion of this Ordinance shall be declared invalid as a matter of law, such declaration shall not affect the remainder of said Ordinance; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect upon passage and publication.
