WHEREAS, THE PROPERTY OWNER SUBMITTED A BILL TO HER HOMEOWNER'S INSURANCE FOR REMEDIATION TO DRY OUT THE FLOOD DAMAGE, FOR WHICH SHE HAD TO PAY A \$750.00 DEDUCTABLE.
