September 10, 2020

The Remote Regular Meeting of the Common Council of Egg Harbor City was held on Thursday, September 10, 2020 at 7:00pm with Mayor Lisa Jiampetti present. Council President Angelo Lello opened the meeting and the following members of Council were present: Mattia Brown, Steve Dash, Donna Heist, Clifford Mays, Jr., Joseph Ricci, Jr., Robert Ross, Robin Sefton and Scott Trythall.(Due to Covid-19 Pandemic and social distancing requirements, the meeting was held via zoom, call in and in person, five members of the Governing Body and invited guests could attend in person.)

Council President Angelo Lello called the meeting to order and made the following announcement:

Upon motion of Ross, seconded by Brown and carried, the August 27, 2020 Council Meeting Minutes was approved.

Council Pres. Lello asked if anyone from the public had any comment on any item on the agenda and there was no comment from the public.

Mayors Presentation: Mayor Jiampetti presented the EHC Citizenship Awards to Dana Seaver and Frank Allebaugh. Mayor Jiampetti presented the Outstanding Church Award to the First Baptist Church, Pastor Paul Ort.

Mayor Report:

Mayor Jiampetti stated she received a letter from the Teamsters 331. Mayor Jiampetti stated the union contract is up the end of 2020 and they are looking to open negotiations soon. Mayor Jiampetti went over the EHC Lake report. Mayor Jiampetti stated three new police officers were hired this week. Mayor Jiampetti when time allows they will come before the Governing Body to be sworn in publicly. Mayor Jiampetti stated the mural on Philadelphia Avenue is still in progress and should be completed soon. Mayor gave an update on the Tower Site and Wawa Project. Mayor Jiampetti stated the Rotary Club has changed the date of the EHC Halloween Parade to Friday, October 30, 2020. Mayor Jiampetti stated they would like to set up a meeting with the City. Mayor Jiampetti stated the American Legion will be holding a ceremony at the hall on Veterans Day. Mayor Jiampetti stated she would like to get Councils approval to hold the EHC Tree Lighting on December 5th and the EHC Christmas Parade on December 19, 2020. Upon motion of Heist, seconded by Sefton and carried approval was given for both events. Mayor Jiampetti stated the EHC Community School was the recipient of the 21st Learning Grant for firve years. Mayor Jiampetti stated a plaque was placed at the Kaboom Playground in memory of Freddie Vaccaro. Mayor Jiampetti thanked Ryan Hacker owner of the Grubbing Gringos food truck for coming out to the lake this summer and selling food. Mayor Jiampetti asked everyone to remember September 11th and to keep in mind all those who sacrificed so much on that date.
