#### July 16, 2020

Council President Angelo Lello called the meeting to order and made the following announcement:

Mayor Jiampetti read the lake report. Mayor Jiampetti stated the fireworks held on July 11<sup>th</sup> at the EHC Lake were a huge success. Ms. Galloway stated she forwarded an ordinance she found from another town on bamboo to the Ordinance Committee. Ms. Galloway asked

the committee to review this ordinance. Ms. Galloway stated she felt the City should ban the planting of bamboo. Ms. Galloway stated the public comment on agenda items needs to be placed back on Council Meeting agendas. Ms. Galloway stated the public should be able to comment on agenda items before they are voted on. Mayor and council agreed and said it would be back on agendas moving forward, even if the meetings are remote. Ms. Galloway asked if the City could be sited since the Renault signs are in the ROW. Ms. Galloway stated she thought the Clean Community Grant should be used differently. Ms. Galloway stated she did not think it should be used on the City Wide Clean Up, she thought a better use would be to by trash cans for residents. Ms. Galloway stated the terrace behind her home is full of trash. Ms. Galloway stated she did not approve of the City waiving the plan review fee for GEHRHS. Ms. Galloway gave an update on the Green Team. Ms. Galloway stated if membership did not improve on the EHC Green Team, there will be no EHC Green Team.

Council Pres. Angelo Lello gave an update on the Peace Pilgrim Statue that was damaged in a recent storm.
