Resolution Authorizing An Amendment To The NPP COVID-19 Relief Program Grant

WHEREAS, on September 24 2020 City Council authorized filing an application with the Department of Community Affairs (DCA) for up to \$85,000 in Commercial Corridor COVID-19 Relief Program funding. Pursuant to this application the Neighborhood Preservation Program (NPP) was to use the funding to provide direct business support and district wide improvements and to administer the program; and,

WHEREAS, on October 16 2020 the City was awarded Grant #2020-02242-0347-00 for the full amount applied for. The NPP has subsequently used over 80% of the funding for direct business support. Although all funding has been spent or committed additional direct business support and district wide improvements are needed; and,

WHEREAS, the City has been made aware that the DCA may have additional COVID-19 Relief Program funding that the City can request through the grant amendment process.

THERFORE, BE IT RESOLVED that if additional COVID-19 Relief funding becomes available, City Council does hereby authorize amending Grant #2020-02242-0347-00 to request up to an additional \$105,000 in funding, and, upon receipt of the grant amendment from the New Jersey Department of Community Affairs, does further authorize the execution of said amendment; and also, upon receipt of the fully executed amendment from the Department, does further authorize the expenditure of funds pursuant to the terms of said amendment between the City and the Department of Community Affairs,

BE IT FURTHER RESOLVED, that the Mayor is authorized to sign the amendment and any other documents in connection therewith.

WHEREAS, the Chief Financial Officer has certified the availability of funds requirements – N.J.A.C. 5:30-5.4>.

NOW THEREFORE, BE IT RESOLVED that the Council of the City of Egg Harbor authorizes the Mayor to enter into a contract with Animal Capture & Control as described herein; and,
