James Angeloni member of Egg Harbor City Partners, LLC was present as well as Paul Mutch, Civil Engineer with Stone Field Engineering Company. Mr. Mutch, PE, was sworn in by Leo Manos, Esquire.

This application filed with the Egg Harbor City Planning Board is for minor subdivision approval and "C" variance relief for minimum lot width (proposed Lot 5.01) and any and all other variances or waivers the Board may require and to subdivide the existing Lot 5 into two (2) new lots.

Mr. Mutch described Exhibit A-1, showing where the WAWA will be located at the northern side of the site and the pad site located on the northwest corner of the site intersection of Atlantic and Philadelphia Avenue.
