### November 10, 2022

The Remote and in Person Regular Meeting of Common Council of Egg Harbor City was held on Thursday, November 10, 2022 at 7:00pm with Mayor Lisa Jiampetti present. Council Pro Temp Donna Heist opened the meeting and the following members of Council were present: Kasey Attianese, Mattia Brown(remote), Kim Hesse, Karl Timbers, Scott Trythall and Mason Wright.(Not present Council President Ricci, Dash, and Timbers)

Council Pro Temp Heist called the meeting to order and made the following announcement:

In compliance with the "Open Public Meetings Act" of the State of New Jersey, adequate notice of this meeting of the Egg Harbor City Common Council was provided in the following manner:

Council Pro Temp Heist also stated the meeting is being conducted via Zoom, conference call and in person. The meeting is also being recorded to air on the Egg Harbor City website, Channel 97 and Facebook.

Upon motion of Hesse, seconded by Wright and carried, the October 13, 2022 Council meeting minutes were approved.

Council Pro Temp Heist asked if there was any comment from the public on anything on the agenda, and there was no comment. Candace Negron of Buffalo Avenue came before Mayor and Council. Ms. Negron stated she was resigning as the NPP Grant Coordinator affective 12/31/2022. Ms. Negron handed the letter of resignation to the City Clerk. Ms. Negron expressed her concerns with drugs in the City. Ms. Negron mentioned how the drug problem in the City has recently impacted the Fire House Pub and Grill. Art Ward of Port Republic, an employee of the Firehouse Pub and Grill, also came forward to speak. Mr. Ward stated the way the City sets up for festivals adversely affects the Firehouse Pub's Business. Mr. Ward stated the 100 block of Philadelphia Avenue should not be blocked when there are festivals. Mr. Ward questioned the use of the lot next to Crossroads during festivals. The City Clerk stated in order to operate on the lot during festivals you would need a permit from the NJABC. City Clerk Meg Steeb asked Mr. Ward to get in touch with her so she could explain he process. Mr. Ward expressed his concerns with drugs, and how the City was addressing these issues. Nanette Galloway of Buffalo Avenue had questions on a few of the resolutions on the agenda, and her questions were addressed. Tracey Mulherin of Arago Avenue had a question on Ordinance #17-2022 on the agenda. Ms. Mulherin had questions on the who will provide the electric. City Engineer Ryan McGowan addressed Ms. Mulherin's question.

Mayors Report: Mayor Jiampetti stated the Veteran's Day service scheduled for 11/11/2022 at the American Legion has been cancelled due to weather. Mayor Jiampetti Mayor's walk will be held on 11/12/2022. Mayor Jiampetti spoke on this year's Holiday House Decorating contest. Mayor Jiampetti also gave an update on the NPP Grant Program, and how the City looks to move forward since the resignation of the

coordinator. Mayor Jiampetti stated she has been in contact with the NJDCA, and the EHCEDC. Mayor Jiampetti stated if everything goes as planned the EHCEDC will be taking over the NPP Grant implementation. The State has recommended hiring Triad handle the grant spending, and to submit the final financial reports for 2022. Mayor Jiampetti stated she has a quote from Triad to complete the work for \$8,750.00. Mayor Jiampetti stated she has spoken to Council Pres. Ricci, and he is in favor of hiring Triad. Mayor Jiampetti stated the fee will be come out of the grant for administrative fees.
