Mayor and Council Comments: Mayor and Council gave their condolences to EHC Employee Karen Lucca for the loss of her son. Galloway stated there will be a ribbon cutting ceremony for opening of the Nature Trail at the City Lake Park on Friday, July 14, 2023 at 4:00pm. Wright, Clark and Attianese gave an update on the EHC Crusaders.

Public Comment: Mr. Lamkin came before Mayor and Council for an update on the flooding on the 400 block of 3<sup>rd</sup> Terrace. City Engineer Ryan McGowan stated there is a plan in place to correct the problem. City Engineer explained the problem in 3<sup>rd</sup> Terrace and discussed the proposed repair. Mr. Lamkin asked what if that plan does not work. Mark Woerner also expressed his displeasure with the flooding in the 400 block of 3<sup>rd</sup> Terrace. Mr. Woerner and Mr. Lamkin did not feel the repair would work. City Attorney Costigan stated the City Engineer has a plan. Ms. Costigan asked if they wanted the City to move forward with the plan. Mr. Woerner stated yes. Mr. Woerner stated he has been putting up with the flooding for 7 years. Councilwoman Hesse asked if the City could get a second opinion on the repair. Costigan explained the process for a second opinion. Mayor and Council agreed the process was too long for a second opinion. Council Pres. Ricci stated he did not feel Council should vote on the repair at this time. Ricci stated Council should have time to review the conceptual plan the Engineer has prepared for the repair. Ricci stated he would set up a Committee meeting. Councilwoman Attianese asked the City Engineer if he could provide an update to Council. Attianese stated several members of Council are not familiar with the flooding problem on the 400 block of 3<sup>rd</sup> Terrace, and McGowan stated he would send an update to Mayor and Council. Councilman Dash suggested Council visit the site. Dash stated it is not an easy fix. Upon motion of Wright, seconded by Dash and carried, the meeting was adjourned.
