## January 20, 2022

The Remote and in Person Regular Meeting of Common Council of Egg Harbor City was held on Thursday, January 20, 2022 at 6:30pm with Mayor Lisa Jiampetti present. Council President Ricci opened the meeting and the following members of Council were present: Mattia Brown, Steve Dash, Donna Heist, Kim Hesse, Robin Sefton and Karl Timbers.(Not present Scott Trythall and Mason Wright)

Council President Ricci called the meeting to order and made the following announcement:

In compliance with the "Open Public Meetings Act" of the State of New Jersey, adequate notice of this meeting of the Egg Harbor City Common Council was provided in the following manner:

Council President Ricci also stated due to the Covid-19 Pandemic and social distancing requirements, the meeting is being conducted via Zoom, conference call and in person. The meeting is also being recorded to air on the Egg Harbor City website ad Channel 97.

Council Pres. Ricci stated it was necessary for Common Council to hold an Executive Session at this time to discuss personnel matters. Upon motion of Heist, seconded by Sefton and carried, Resolution #28-2022, attached hereto and made a part of these minutes was approved.

Upon motion of Heist, seconded by Dash and carried, Executive Session was adjourned. City Attorney Angela Costigan stated in Executive session Mayor and Council were updated on the City's Layoff Plan submitted to New Jersey Civil Service Commission in August of 2021.

Upon motion of Heist, seconded by Sefton and carried, the December 15, 2021 "Special Meeting" minutes and the January 5, 2022 Reorganization meeting minutes were approved.

Council Pres. Ricci asked if there was any comment from the public on anything on the agenda. Nanette Galloway Buffalo Avenue asked for the NJ Clean Energy Program Community Energy Planning Grant Program Resolution be explained, and EHC CFO Jodi Kahn explained the resolution.

Mayor Presentation: Mayor Jiampetti presented trophy's and gift certificates to the winners of the 2021 Holiday Light Display Contest.

Mayor Jiampetti gave a presentation on Strategic Planning in Egg Harbor City. Mayor Report: Mayor Jiampetti gave an update on the Wawa project in EHC. Mayor Jiampetti stated she met with Hector Taverez to discuss bringing a PAL to EHC. Mayor Jiampetti stated also in attendance at this meeting was Councilwoman Hesse, a representative of Key Rec, Candance Negron and the EHC Police Chief Aylwin. Mayor Jiampetti stated Mr. Taverez would like to come to the February 24, 2022 Council meeting to address Council and the public regarding an EHC PAL. Mayor Jiampetti stated the EHC Coalition for a Safe Community will be bringing a wrestling program to EHC Community School. Mayor Jiampetti stated the EHC Bowling Alley was sold. Mayor Jiampetti stated two new homes are going to be built on two City owned lots that were recently sold by George Frick. Mayor Jiampetti asked Council to consider adding a report by the Superintendent of Public Works to the Council Agenda, and Council agreed to add the report to the agenda.

The NPP Grant Coordinator, Candace Negron gave an update on the NPP Grant Program.

Committee Chair Reports: Councilman Timbers gave an update on the EHC Land Use Board and Eyren Hafen. Councilman Dash read the Code/Building Department Report. Dash stated there are 741 residential rental units registered in the City. Council Pres. Ricci sated he will be setting up a Finance Committee meeting, and he encouraged the other Committee Chairs to do the same with their committees. Councilman Trythall and Councilwoman Brow stated they will be setting up meeting in the near future.

Chief of Police Report: Chief of Police Marcell Aylwin gave an update on the EHCPD. Chief Aylwin mentioned a letter sent to the City from a resident regarding excessive speeding. Chief Aylwin stated the issue is being addressed.
